The Board approved the Executive Director's salary based on this review. For the Hamlet House manager, the board utilized typical WA state compensation figures provided by a couple of Adult Family Home experts that have no connection to The Hamlet to determine her salary. In 2025, the Executive Director and managers received a cost of living increase that was also approved by the Board.

These prior period adjustments were made in accordance with accounting standards to ensure accurate presentation of net assets.
